- Transfer papers are normally in the form of a pink (duplicate) copy of a triplicate form signed by the breeder. If the breeder has supplied you with the yellow (original) copy you will be required to pay the transfer fees (\$15.00 per ram; \$3.00 per ewe).
- The ASSBA also has an on-line system of registering and transferring animals to a new breeder.
 Therefore if your animals have been transferred electronically the breeder will probably not
 provide you with a duplicate copy of the transfer. However, there will be a copy on file at the
 office so kindly check to ensure your animals have been transferred and fees paid.
- Where transfers have not been provided to you, or to the office, you will be responsible to follow up the breeder to organise this.
- **Please note:** it is preferable that your flock is registered within 120 days from the date of purchase. If not, the Board may require an inspection to be carried out.
 - You will be responsible to bear the cost of any such inspection and to accept the decision of the Board as to the acceptance or refusal of the whole or any of your sheep for registration in the Flock Register.
